Seventeen innovative studies are collected in this volume which has been produced under the aegis of the Centre for Biblical Studies, University of Manchester, and L'Institut des sciences bibliques, Universite de Lausanne. The majority of the studies engage with narrative through providing insightful working examples. Building on the many contributions of recent narratological research, for the most part the studies in this collection avoid the technical language of narratology as they present fresh insights at many levels. Some essays focus more on the implied author, some on the implied reader or hearer, and some on the way particular messages are constructed; some of the studies consider how author, message and reader are all interconnected. There are several creative proposals for refining genre definition, from law and wisdom to gospel and apocryphal writings. Some studies highlight the way in which narratives can contain ethical, religious, and cultural messages. Sensitivity to narrative is also shown by some contributors to expose in intriguing ways the redactional processes behind the final form of texts. Students of narrative in the ancient world will find much to consider in this book, and others engaged with literary studies more generally will discover that scholars of the worlds of the Bible and Late Antiquity have much to offer them.

The International Tribunal for the Law of the Sea was established under the 1982 United Nations Convention on the Law of the Sea as an independent, international judicial body with competence to settle disputes concerning the interpretation or application of the Convention, pursuant to other international agreements which confer jurisdiction on the Tribunal. The Tribunal is open to States parties, international organizations and other entities as provided for in the Convention or other agreement. The Seabed Disputes Chamber of the Tribunal has compulsory jurisdiction with respect to seabed disputes between various entities including States Parties, the International Seabed Authority and private corporations and individuals. The Tribunal has special jurisdiction to deal with urgent requests for the prompt release of vessels and crews and for prescribing provisional measures. It also has competence to give advisory opinions. This volume contains a selection of documents that are basic to the work of the Tribunal in parallel presentation in English and French. It reproduces the Statute of the Tribunal, the Rules of the Tribunal, the Resolution on the internal judicial practice and the Guidelines concerning the preparation of cases. It also contains the 1982 United Nations Convention on the Law of the Sea, the Agreement relating to the Implementation of Part XI of the Convention on the Law of the Sea and the Agreement on the Privileges of the Tribunal. ## **Current Marine Environmental Issues and the International Tribunal for the Law of the Sea**

The metalinguistic dimension refers to the way in which learners bring to bear knowledge about language into their learning of a second language, the "L2". This book brings together new research on the metalinguistic dimension, given its increasing importance in the study of L2 acquisition. In applied linguistics it is widely accepted that L2 learners develop and use knowledge about language when engaging with the challenging task of acquiring a new language; this applies to both children and adults. It is definitions of the metalinguistic dimension that vary, and findings regarding its role in L2 learning are not necessarily homogenous or compatible. The scope exists for further, empirical, detailed research. This book

explores the nature, development and role of the metalinguistic dimension and will be essential reading for all SLA scholars and those working in language and education.

## **The Italian Yearbook of International Law**

By 1520, Niccolò Machiavelli's life in Florence was steadily improving: he had achieved a degree of literary fame, and, following his removal from the Florentine Chancery by the Medici family, he had managed to gain their respect and patronage. But there is one figure whose substantial contributions to Machiavelli's restoration has been hitherto neglected - Lorenzo di Filippo Strozzi (1482-1549), a younger and fabulously wealthy Florentine nobleman. As manuscript evidence suggests, Strozzi brought Machiavelli into his patronage network and aided many of his post-1520 achievements. This book is the first English biography of Strozzi, as well as the first examination of the patron-client relationship that developed between the two men. William J. Landon reveals Strozzi's influence on Machiavelli through wide-ranging textual investigations, and especially through Strozzi's *Pistola fatta per la peste* - a work that survives as a Machiavelli autograph, and for which Landon has provided the first ever complete English translation and critical edition.

### **Current Publications in Legal and Related Fields**

Volume 13 of the Yearbook of the European Convention on Human Rights relates to the year 1970 and reflects a return to the usual pattern of activity under the Convention during that year, after the exceptional situation produced in 1969 by the "Greek Case". This volume is published somewhat later than usual, because an extra volume in this series has been published between volumes 12 and 13 containing the Report of the European Commission of Human Rights and the Resolution of the Committee of Ministers of the Council of Europe relating to the "Greek Case". Part I of this Volume contains, as usual, the basic texts, chief among which are the amendments now made to the Convention following the entry into force on 21 September 1970 of the Third Protocol, which relates to the procedure of

the Commission. On the same date, the Second Protocol also entered into force, conferring on the Court of Human Rights competence to give advisory opinions. The text of this Protocol is to be found in Volume 6 at pages 3ff. The amendments and additions to the Rules of Court consequent upon the entry into force of the Second Protocol are set out in Part I of this Volume.
