Fragmentation in Semi-Arid and Arid Landscapes

Coastal and marine ecosystems, some severely degraded, other still pristine, control rich resources of inshore environments and coastal seas of Latin America's Pacific and Atlantic margins. Conflicts between the needs of the region's nations and diminishing revenues and environmental quality have induced awareness of coastal ecological problems and motivated financial support for restoration and management. The volume provides a competent review on the structure, processes and function of 22 important Latin American coastal marine ecosystems. Each contribution describes the environmental

settings, biotic components and structure of the system, considers trophic processes and energy flow, evaluates the modifying influence of natural and human perturbations, and suggests management needs. Although the focus of the book is on basic ecological research, the results have application for coastal managers.

Saponins in Food, Feedstuffs and Medicinal Plants

This book analyses the housing and governance policies of the city of Surakarta, in Indonesia. It addresses the question of whether Surakarta's strategy for handling the city's informal sector and marginal settlements shows evidence of sustainability and good governance. The book illustrates current trends in urban development and discussions on effective strategies for improving living conditions in slums on both a global and national scale. Using four main programs as examples, it presents a detailed overview of Surakarta's housing policies regarding the poor. It critically evaluates the city's relocation measures and shows that Surakarta's city government has put into place an effective policy, reaching the poor by inclusive approaches. Influenced by global discussions and best practices, the programs examined are characterized by elements of good governance and Solo's strategies have already been disseminated to other Indonesian cities. However, the book argues that deficits remain regarding participation and transparency. The work is based on Christian Obermayr's outstanding Master's thesis, defended in 2013 at the University of Innsbruck, Austria.

The Structuring of Organizations

The early history and development of the field of glycolipids was concerned mainly with the predominant glycolipids found in higher animal tissues, namely the glycosphingolipids, as has been extensively documented by J. N. Kanfer and S. Hakomori in Volume 3 of this series. The major glycolipids in organisms of the plant kingdom, however, such as bacteria, yeasts and fungi, algae, and higher plants, are glycoglycerolipids, although glycosphingolipids are also present as minor components in these organisms, except for bacteria. It is of interest that one of the pioneers in glycosphingolipid research, Herbert E. Carter, also pioneered the discovery and structural elucidation of the plant galactosyldiacylglycerols. This class of glycolipids is present in chloroplast membranes and must surely be one of the most ubiquitous and abundant natural substances in the world, thereby deserving the attention of lipid biochemists. It is therefore surprising to learn that in contrast to the glycosphingolipids, which were discovered in the 1870s, glycoglycerolipids were not discovered until the 1950s. Since that time investigations of the structure and distribution of these glycolipids have proceeded at an exponentially increasing rate, and much information is now available for representatives of many genera of bacteria, yeasts, algae, and higher plants. Glycoglycerolipids have also been identified in animal cells, particularly in the brain, testes, and sperm.

The authors also explain how efficient dispersal mechanisms employed by the nuisance mollusks not only help them spread so rapidly to inland lakes and rivers across continents, but how they can invade virtually every part of a facility. While many other resources contain segments of this information, none cover all areas and link them in a cohesive fashion. It is this approach that makes the understanding of potential impacts on ecosystems, industries and utilities, as well as the many human-made physical and chemical mitigants for controlling the mollusks supplied by this book so crucial for preserving the health of raw water supplies.
