## The Quest for Context and Meaning

This book is about the size, the shape and the architectural nature of the Globe playhouse of Shakespeare's time, the most important theatre in English history. The design of the second Globe, and by extension the first, has been a subject of keen debate for many years, fostered by recurrent attempts to reconstruct the playhouse, both in London and Detroit. Professor Orrell here offers fresh ways of looking at some well-known documents and newer evidence. By using detailed diagrams and seventeenth-century panoramas, the author is able to establish the accuracy of Hollar's famous 'Long View' of London, and by reconstructing his methods arrives at an exact measurement of the diameter of the second Globe. These findings document many advances in our hard knowledge of the theatre buildings of Shakespeare's time, to the point where reconstructions may be undertaken with confidence.

## Reading Quest PRO

This is a study of issues in good governance in South Asia, viz. in the countries of India, Pakistan, Sri Lanka and Nepal. The focus is on the interconnections between governance, decentralization (of authority and decision making) and poverty eradication. The book submits a stratagem to turn South Asia's greatest handicap, poverty, into a source of strength, in which the poor contribute directly to growth. The key to this pro-poor growth strategy, according to the authors, is community mobilization through social movements and non-governmental development initiatives. The book is divided into three parts, the conceptual framework, illustrative case studies and lessons for macro/microeconomic policy. Part I

critically evaluates conventional developmental thinking and suggests the outline of an alternative pro-poor developmental strategy. Part II, the backbone of the volume, is a collection of six case studies from selected locations in south Asia, covering both rural and urban experiences. Part III draws lessons from these studies for a value-driven policy with both short-term and long-term implications. The book is a first of its kind, examining in-depth issues of vital importance to the development of the South Asian region. The importance of this volume lies in the synthesized lessons for policy and implementation drawn from cases where new ground has been broken in the conceptualization of social mobilization and pro-poor growth.

The idea of koinonia has gained prominence in recent ecumenical discussions. Lorelei Fuchs proposes the theological concept of koinonia, loosely translated as communion, as the key to moving the fractured churches toward a future unity. Fuchs challenges churches to move beyond mere dialogue to apply their ecumenical insights at the local level. She begins by relating the exegetical meaning of koinonia to its ecumenical meaning, tracing the place of koinonia both within the churches and between the churches. She then examines the concept in the extensive and fruitful dialogues that have taken place between Lutherans, Anglicans, and Roman Catholics, finally articulating a symbolic competence for communionality that provides a rich and workable way forward for church unity at all levels. Encompassing the latest in ecumenical thought within the Catholic, Anglican, and Lutheran milieu, *Koinonia and the Quest for an Ecumenical Ecclesiology* provides a framework for moving closer to the reality of Christ's prayer that all may be one.

Other chapters propose improved monetary frameworks for Argentina, Brazil, India, Mexico, the Philippines, South Africa, Turkey, and Vietnam. Policy frameworks that are explored include employment targeting, and targeting a stable and competitive real exchange rate. The authors also show that to reach a larger number of targets, including higher employment and stable inflation, central banks must use a larger number of instruments, including capital management techniques. This volume offers concrete, socially valuable alternatives that economists, policy makers, students and interested laypeople should consider before adopting one size fits all, often inadequate, policies that have become a virtual policy making fad.

Starting from the premise that democracy is more than simply a matter of universal suffrage and the holding of regular multiparty elections, and that development is about much more than growth of GDP, this Report focuses on how to make democracy work for pro-poor development and on development policies that in themselves uphold and promote democratic values. It argues that development and democracy are not only goals in their own right but must also be mutually reinforcing. Pro-poor development recognises that people need the 'capabilities' to do and be the things that they have reason to value, such as being adequately nourished, having equitable access to justice and participating in decisions that affect their lives. It also recognises that development policies aimed at the general populace may have a more limited positive impact on particularly disadvantaged groups. Such groups need to be identified (for example, in terms of gender, ethnicity, religion, age or occupation) and policies need to be specifically designed for improving the lives of the poor. The Report argues that governments, the private sector, civil society and the international community each have a vital role to play in delivering development and democracy, and calls for responsibility, partnership and concrete actions from all these actors. Without responsibility on all these levels, development and democracy will remain rhetoric rather than become reality. Prepared by the Commonwealth Expert Group on Development and Democracy at the request of Commonwealth Heads of Government, the Report contains a number of recommendations for action at the national and international levels. It will be of interest to policy-makers, multilateral and bilateral agencies, the private sector, civil society organisations and all those committed to development, democracy and the achievement of the Millennium Development Goals.
